

RECOMMENDATIONS:

Use PEPPZYME with a good fertilizer program under BFMS guidelines for better soil and water management and to improve crop production.

APPLICATIONS AND DIRECTIONS:

Pepzyme G is designed for use on soils and canopied crops such as turf. It may be applied to the soil by aerial spraying, ground sprayer, shanked in with fertilizer liquids, through seed drill starter-fertilizer application, through sprinkler systems or by furrow or flood irrigation. Pepzyme can be applied with most liquid fertilizer, herbicides and pesticides. Apply Pepzyme at the rate of 12.5 ounces per acre or 1 gallon per 10 acres (0.94 liters per hectare). Dilute with sufficient water to get uniform coverage of the soil. Apply just before, during, or immediately after planting for maximum benefits. Apply on crop residues after harvest, prior to tillage, to promote decomposition and soil improvement. May be applied to fallow or re-crop ground prior to fall planting, or in preparation for spring crops. Apply Pepzyme anytime there is adequate moisture available to move it into the soil, incorporating with shallow tillage to increase effectiveness, especially when conditions are drier.

FOR GREENHOUSE AND NURSERY:

Mix 1 part Pepzyme in 4000 parts water and apply resulting solution at the rate of 60ml per plant in greenhouse beds or pots.
